

## THE P G WODEHOUSE SOCIETY (UK) MEMBERSHIP APPLICATION FORM

The annual subscription is £22, and our membership year runs from 1 June to 31 May. People joining partway through the year may pay a pro-rata subscription to take them to the end of their first membership year, and then renew at the full annual rate.

If you live outside the UK, you may pay your membership in US dollars if you prefer; the annual rate is \$40.

*The subscription rates are as follows:*

£22.00 / \$34.00 if joining in June–end of November – includes four issues of *Wooster Sauce*, our quarterly magazine (June, September, December, March)

£11.00 / \$16.50 if joining in December–end of May – includes two issues of *Wooster Sauce*, our quarterly magazine (December, March)

The Society's preferred payment method is Direct Debit, easily set up by applicants with a UK bank or building society account. Please see below and the Direct Debit guarantee on the second page of this form.

For overseas members unable to do this, we accept payment via PayPal or International Funds Transfer (IFT); see below for details. For your own security, we recommend that you do not send cash in any currency by post.

**The Direct Debit Guarantee** 

- This Guarantee is offered by all banks and building societies that accept instructions to pay Direct Debits.
- If there are any changes to the amount, date or frequency of your Direct Debit, The P G Wodehouse Society (UK) will notify you five working days in advance of your account being debited or as otherwise agreed. If you request The P G Wodehouse Society (UK) to collect a payment, confirmation of the amount and date will be given to you at the time of the request.
- If an error is made in the payment of your Direct Debit by The P G Wodehouse Society (UK), your bank or your building society, you are entitled to a full and immediate refund of the amount paid from your bank or building society.
- If you receive a refund you are not entitled to, you must pay it back when The P G Wodehouse Society (UK) asks you to.
- You can cancel a Direct Debit at any time by simply contacting your bank or building society. Written confirmation may be required. Please also notify us.

The personal information you have provided on this form is used by the Society to enable us to run the Society, maintain Society records, advise you about Society events, send you copies of our quarterly journal *Wooster Sauce* and other publications, advise you of events and publications which may be of interest to you, and remind you when your subscription is due. This includes contacting you by post, telephone, and email.

Your information will never be passed on to third parties without your express written consent nor will it be used or sold by us for marketing purposes under any circumstances.

The information is stored on an encrypted database on an encrypted computer which is not connected to the internet and is only used when it is needed to facilitate the running of the Society and provide the benefits of membership to you. Whether you pay your subscription by cheque, by Direct Debit, through PayPal, or by Standing Order, your bank details are held securely and separately from your other personal details. Information held by GoCardless, PayPal and Barclays Bank is protected by industry standard encryption.
